In consideration of the agreement herein, Hadley Inc. d.b.a. M&M Rental does lease to the undersigned (hereafter referred to as the LESSEE) the craft and equipment described herein. LESSEE agrees said craft will not be occupied by a greater number of persons than is shown in this agreement.

THE LESSEE CERTIFIES THAT HE/SHE HAS EXAMINED THE CRAFT AND EQUIPMENT AND FINDS IT ACCEPTABLE AND SUITABLE FOR THE PURPOSE FOR WHICH IT IS LEASED. THAT HE/SHE WILL OPERATE AND MAINTAIN BOTH THE CRAFT AND EQUIPMENT IN A SAFE, DEPENDABLE CONDITION IN ACCORDANCE WITH ALL SAFETY RULES AND REGULATIONS AS PROVIDED OR ON THE CRAFT WHILE IN HIS/HER CUSTODY, AND FURTHER CERTIFIES THAT HE/SHE HAS READ AND UNDERSTANDS SAID RULES AND REGULATIONS.

LESSEE AGREES TO REPORT ANY ACCIDENT, MALFUNCTION OR BREAKDOWN OF RENTAL CRAFT TO HADLEY INC. D.B.A. M&M RENTAL IMMEDIATELY. CONTINUED USE OF IT SHALL BE ENTIRELY AT THE LESSEE'S RISK AND THUS LESSEE ASSUMES ALL LIABILITIES OF INJURY AND DAMAGE TO ALL PERSONS AND PROPERTY THAT MAY BECOME INVOLVED BY ITS CONTINUED USE.

LESSEE agrees not to use, nor permit the use: (A) of the rental craft for any unlawful purpose; (B) of the rental craft in a careless or negligent manner; (C) of the rental craft while under the influence of liquor and/or narcotics; (D) of the rental craft by any other person not the signatory of this agreement, or not equally qualified.

**LESSEE acknowledges his/her responsibility for the safe and proper operation of the craft; and for the safety and welfare of other boaters and persons. It is AGREED AND UNDERSTOOD BY LESSEE that HADLEY INC. d.b.a. M&M RENTAL shall not be held liable for damages, inconvenience or time lost caused by accident, breakdown or malfunction of the rental craft. LESSEE FURTHER AGREES to indemnify and hold harmless HADLEY INC. d.b.a. M&M RENTAL from, and against any and all claims for loss of or damage to property or injury to persons (including death) resulting through the use, operation or possession of said rental craft. LESSEE further agrees to hold HADLEY INC. d.b.a. M&M RENTAL harmless should loss or damages occur to any of the LESSEE'S personal property while carried in, or on, the rental craft, including loss or damage caused by fire, water, theft or any other cause whatsoever.**

LESSEE expressly agrees to indemnify and hold HADLEY INC. d.b.a. M&M RENTAL harmless of, from and against any and all loss, costs, damages, attorney fees and/or liability in connection with the enforcing of this agreement by HADLEY INC. d.b.a. M&M RENTAL, including expenses incurred in collection or attempting to collect delinquent rent and in the event of suit by HADLEY INC. d.b.a. M&M RENTAL to recover possession of said rented property and/or to enforce any of the terms, conditions and/or provisions there of, it is understood and agreed that Venue of any action hereunder shall be in the county and state of HADLEY INC. d.b.a. M&M RENTAL. This agreement shall be governed by the laws of the state of HADLEY INC. d.b.a. M&M RENTAL.
